# B.E.S.T. IN CLASS

Congratulations to the 94 nursing homes across Colorado, Illinois, Iowa and Oklahoma who provided safe and quality care to their residents by achieving Telligen's B.E.S.T. in Class award!



In order to qualify, each nursing home must receive Telligen's Blue Ribbon in COVID-19 Vigilance award for multiple quarters per year, complete Telligen's Emergency Preparedness Assessment, have at least 75% of staff complete infection prevention and control training, and reduce the number of preventable emergency department visits by 5% (or be within the top 25% of Telligen's enrolled nursing homes) or, effective April 2024, improve the number of 30-day all-cause rehospitalizations by 5% (or be within the top 25% of Telligen's enrolled nursing homes).
