In order to qualify, each nursing home must receive Telligen's Blue Ribbon in COVID-19 Vigilance award for multiple quarters per year, complete Telligen's Emergency Preparedness Assessment, have at least 75% of staff complete infection prevention and control training, and reduce the number of preventable emergency department visits by 5% (or be within the top 25% of Telligen's enrolled nursing homes) or, effective April 2024, improve the number of 30-day all-cause rehospitalizations by 5% (or be within the top 25% of Telligen's enrolled nursing homes).
